

## CHROMEBOOK CARE & INTERNET USAGE - NOTIFICATION AND UNDERSTANDING

The Benson Public Schools Chromebook Care and Usage Handbook is available on the Benson Public Schools website at [www.benson.k12.mn.us](http://www.benson.k12.mn.us) and is located under the District Home page - Technology link.

Your signature on this document states that you understand and agree to abide by **Benson Public Schools Acceptable Use Policy (Internet Acceptable Use and Safety Policy)** Your signature also states that you authorize Benson Public Schools to create an account for your child and you give permission for your child to utilize the internet for educational purposes and this “cloud service” account that will be under the control of Benson Public Schools, but which reside elsewhere on the Internet. As per the Acceptable Use policy, any violation of this acceptable use agreement shall result in immediate revocation of internet usage privileges as well as may result in disciplinary action.

As part of the 1:1 Chromebook initiative Benson Public Schools is recommending the purchase of accidental damage insurance prior to the deployment of the Chromebook to your child. Under this insurance agreement, the Chromebooks are protected against accidental damage to the device.

This insurance policy **does not** cover for loss of the Chromebook and/or its accessories (i.e. charger, case) cosmetic damage, or damages caused by intentional misuse and abuse. Tampering with and/or taking the unit apart will void all insurance coverage and result in loss of insurance premium and deductible. **Parents/students will be charged for full replacement cost of a device that has been damaged due to intentional misuse or abuse.**
